Fluxica Peregrine End User License Agreement

This End User License Agreement ("EULA") is a product license, not a sale. Please read this EULA before You purchase a License Key for the Fluxica Peregrine software program and subsequently download and use the Peregrine Program. The Peregrine Program is available in four versions: Demo, Fly, Soar and Stook. The License Key for the Demo version is only valid in combination with a 10 day Trial Key. The combination License Key - Trial Key for the Demo version is available free of charge for evaluation purposes and is in the context of this EULA a License Key purchase with a price of zero.

By purchasing a License Key and/or downloading and using the Peregrine Program, You agree, without reservation to be bound by the terms of this EULA. If You do not agree with the terms of this EULA, please do not purchase a License Key and/or download and use the Peregrine Program.

If You accept the terms and conditions in this EULA, You warrant that You have full legal authority to accept the terms and conditions in this EULA on behalf of a company or other legal entity, and to legally bind such company or other legal entity.

Definitions

In this EULA the expressions below shall have the meaning assigned to them in this clause, unless the context requires otherwise:

- "Documentation": The detailed information of the Peregrine Program as made available in the download of the Peregrine Program. The documentation may be incomplete at any given time and it will be continuously updated.
- "License": The right to use the Peregrine Program under the terms of this EULA.
- "License Key": A unique code assigned to a valid product purchase provided by Fluxica to You the purchaser, which enables You to activate the Peregrine Program and to subsequently use the Peregrine Program. The License Key is uniquely assigned to You and cannot be shared or transferred to other entities or persons.
- "Trial Key": A unique code assigned to the Demo version of the product provided by Fluxica to You, which validates the License Key for a period of 10 consecutive days since the moment of it was downloaded.
- "Fluxica": Fluxica Computer Engineering, the business entity as identified on the www.fluxica/contact.html web page. Fluxica is a business-to-business (B2B) operation in the European Economic Area residing in the Netherlands.
- "Peregrine Program": Any software application and/or all of the contents of the files and/or other media, including software setup files, licensed to You by Fluxica.
- "Node": The number of Nodes per license purchased refers to the number of computers You may Use the Peregrine Program on simultaneously.
- "Use": The access, download, install, copy or get benefit from using the Peregrine Program in accordance with the documentation.
- "You": The final and ultimate user of the Peregrine Program or the authorized representative of a company or other legal entity that will be the final and ultimate user of the Peregrine Program, and the company or other legal entity that will be the final and ultimate user of the Peregrine Program, if applicable.

General

By purchasing a License Key for the Peregrine Program and/or downloading and using the Peregrine Program, You enter into this EULA with Fluxica. This EULA may be modified from time to time and Fluxica will publish such modifications on its www.fluxica.com/eula.html web page. Any modifications to this EULA shall only apply upon acceptance by You.

License

Fluxica grants You a non-exclusive, non-transferable, non-sublicensable, limited, revocable license to Use the Peregrine Program in accordance with this EULA. Fluxica reserves all rights not expressly granted to You. Fluxica is and remains the owner of any intellectual property rights with respect to the Peregrine Program. You shall not acquire any ownership to the Peregrine Program as result of Your purchase of the License Key or Your Use of the Peregrine Program.

Permitted use and restrictions

In order to be able to install the Peregrine Program, Your computer shall meet the system requirements described on the www.fluxica.com/specifications.html web page.

You shall Use the Peregrine Program on one computer only, unless You have purchased more than one Node license. In the event You have purchased more than one Node license, the number of computers You may Use the Peregrine Program on shall not exceed the number of Nodes expressed in the Peregrine Program License. If You exceed the Nodes limit, You are violating this EULA.

You shall Use the Peregrine Program in accordance with applicable laws and shall not:

- Rent, lease, lend, sell, redistribute, sublicense or otherwise commercially exploit the License Key.
- Assign the License Key without prior written approval of Fluxica.
- Use the Peregrine Program for any unlawful or illegal activity, or to facilitate an unlawful or illegal activity.
- Delete or alter any disclaimers, warnings, copyright or other proprietary notices accompanying the Peregrine Program.
- Copy (except as otherwise provided in this EULA), adapt, translate, decompile, reverse engineer, disassemble, attempt to derive the source code of, modify or create derivative works of the Peregrine Program and the License Key or any parts thereof, except to the extent permitted by applicable law.

Maintenance and support
